# 2023 HENDRICKS COUNTY RIB-FEST & BBQ Official Festival Rules

- 1. All vendors must have completed all forms, waivers, and possess current health and vendor licenses. Each vendor is also responsible for providing a certificate of insurance for the day of the event. This certificate should be returned to the chamber office no later than June 2, 2023. It is the responsibility of each individual vendor to ensure that his/her paperwork is in order.
- 2. All vendors must comply with all Hendricks County Health Department requirements and regulations. Should you have any questions regarding the department's requirements for proper hand-washing stations, refrigeration and food handling, you may contact the Hendricks County Health Department (317) 745-9217. All vendors who do not comply with Health Department requirements and regulations run the risk of being shut down by the Health Department the day of the event. No refunds will be given to vendors who are shut down by the Health Department for lack of compliance with Health Department regulations and requirements. If for some reason you do not receive approval to operate from the Health Department, you will not be able to remove your equipment until after the end of the event. The application for a temporary food establishment permit and instructions for temporary sites are available on the county website: http://www.co.hendricks.in.us/.
- 3. All vendors are invited and encouraged to participate in the celebrity rib judge contest which will be judged on their dry ribs and BBQ sauce. There will be no more than 6 judges and each vendor will provide in their own container a dry two-bone portion along with sauce on the side for each judge to participate.
- 4. All vendors must comply with State of Indiana Fire Marshal codes see examples below:
  - a. Multiplug adapters, such as cube adapters, unfused plug strips or any other device not complying with NFPA 70 shall be prohibited.
  - b. Relocatable power taps shall be directly connected to a permanently installed receptacle.
  - c. Compressed gas containers, cylinders and tanks shall be secured to prevent falling caused by contact, vibration or seismic activity.
  - d. Class K portable fire extinguishers required when using deep fat fryers.
- Attendees will purchase sheets of tickets from Chamber Ticket booths. Food tickets will be in \$1.00 & \$5.00 denominations and vendors will need to be prepared to return "change (in tickets)" to guests. Please inform workers that if possible do not tear or fold tickets at the perforations.
- 6. At the end of the day, the vendor MUST deliver the redeemed tickets to the on-site Chamber Office to a Chamber representative. The tickets will be placed in a sealed package to be counted on the next business day and checks will be issued to each vendor after that count. Vendors are invited to schedule a time to be present for the ticket count, but it is not required. <u>There will be a split of 85% to the vendors and 15% to the Avon Chamber of Commerce.</u>
- 7. The Food Vendor's booth must be open and staffed during all event hours. Late arrivals and early departures pose a safety hazard for festival guests no vendors will be permitted to move vehicles, trailers or other large equipment during event hours or before the crowd has dispersed. If you sell out, you must remain on-site for the remainder of the event.
- 8. Vendors will *not* be allowed to sell soft drinks, water or desserts.
- 9. The competitions schedule for judging is as follows:
  - 2:00 PM-3:00 PM –Judging of ribs & sauce

Tickets will be sold until 9:30 pm and the fireworks will begin at dark (approx 10:00pm)

10. Plaques will be awarded for "Best Ribs" and "Best Sauce". All decisions are final.

- 11. Hendricks County Rib-Fest & BBQ vendors will be allowed to clean-up any time after 10:00pm and will be allowed to pack up and leave the park <u>following</u> the fireworks show. Arrival time instructions will be discussed at the Vendor meeting & sent out via email.
- 12. Each vendor is responsible for proper disposal of trash, grease and other debris from their space. Do not dump ice on the grass. Please leave your area the way you found it Thank you!

### **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return.
