1. Vendors/Sponsors/Exhibitors can begin setting up on Friday, June 26<sup>th</sup> but must be set-up and vehicles moved to parking lot no later than 9:00am on Saturday, June 27<sup>th</sup> on the day of the event. **ABSOLUTELY NO EXCEPTIONS!** All Vendors/Sponsors/Exhibitors will receive a confirmation email regarding loading and teardown instructions and 2 vehicle passes. The booth does not need to be attended the entire day, however, it **MUST** be set-up by 9:00am and torn down any time after 6:00pm on Saturday, June 27<sup>th</sup>.
2. **RETAIL SALES OPPORTUNITY**  
New this year, Vendors/Sponsors/Exhibitors are permitted to sell products directly from their booth during the Business Expo. **Please Note: NO water or soft drinks sales or distribution are permitted.**
3. Vendors/Sponsors/Exhibitors are responsible for their own signage, tents, tables and equipment.
4. No alcoholic beverages of any kind are permitted to be sold, stored or consumed outside of the permitted alcohol area at any time before, during or after the Rib-Fest.
5. The Hendricks County Rib-Fest & BBQ Business Expo will take place from 10:00 AM to 6:00 PM. Vendors/Sponsors/Exhibitors may begin cleanup at 6:00 PM and are permitted to pack up and exit the park at that time. However, vehicles are strictly prohibited from entering the pavilion at any point during the event, including for loading purposes. **ABSOLUTELY NO VEHICLE MOVEMENT WILL BE ALLOWED IN THE PAVILION DURING EVENT HOURS.**
6. Vendors/Sponsors/Exhibitors are responsible for providing necessary trash bags and properly bagging and disposing of all garbage from your booth. Dumpsters will be available for disposal of garbage. Please leave your area the way you found it. Do not dump ice on grass. Concrete is ok - Thank You!
